Probationary Period Introductory period of employment that allows the employee and agency to determine if the employee is suited for the job During the probationary period, employees may be terminated at the pleasure of the appointing authority, without access to the State Grievance Procedure The normal probationary period is 12

**Generating and Maintaining ACA Period Records**
